EXECUTIVE ORDER A-162-12  
Relating to Certification of New Heavy-Duty Motor Vehicles

HOLIDAY RAMBLER CORPORATION

Pursuant to the authority vested in the Air Resources Board by Sections 43100, 43102, and 43835 of the Health and Safety Code; and

Pursuant to the authority vested in the undersigned by Sections 39515 and 39516 of the Health and Safety Code Executive Orders G-45-3 and G-45-4;

IT IS ORDERED AND RESOLVED: That 1989 model-year Holiday Rambler Corporation motor vehicles which have a manufacturer's gross vehicle weight rating (GVWR) of 8501 to 14,000 pounds are certified using the gasoline engines listed below:



BE IT FURTHER RESOLVED: That the Executive Officer has been provided all material required to demonstrate certification compliance with the Board's emission control system warranty provisions (California Health and Safety Code Section 43205.5).

Engines certified under the Executive Order must conform to all applicable California emission regulations.
