SUBJECT: PUBLIC WORKSHOP TO DISCUSS POSSIBLE MODIFICATIONS TO  
THE ZERO EMISSION VEHICLE REGULATIONS

---

At its September 7 and 8 meeting, the Air Resources Board considered the status of the Zero Emission Vehicle (ZEV) program. After hearing extensive testimony and public comment, the Board by unanimous vote adopted a resolution affirming that the ZEV program is an essential component of the State's long-term air quality strategy. The Board further resolved that the basic ZEV requirements be retained and implemented in California. Finally, the Board directed staff to develop and propose regulatory modifications and other steps that address the challenges associated with the successful long-term implementation of the ZEV program, and that result in a sustainable market for ZEVs. In particular the Board identified the need for near-term product availability and market stability, the need to greatly enhance public education regarding the attributes and benefits of ZEV technologies, and the need to reduce or mitigate the high initial costs of vehicles and batteries in low-volume production.

In response to the Board's directive, staff will be developing recommendations to be brought before the Board at a January 25, 2001 public hearing. As a first step in developing possible regulatory changes, staff will hold a workshop to present possible approaches and receive public comment.
