Dear Ms. Yoshii:

The Air Resources Board (ARB or Board) hereby submits to the U.S. Environmental Protection Agency (U.S. EPA) *Amendments (Amendments) to the San Joaquin Valley 2007 Ozone Plan (2007 Ozone Plan)* as a revision to the California State Implementation Plan (SIP) as requested by your staff.

These Amendments update the rulemaking schedule for the San Joaquin Valley Air Pollution Control District's (District) commitment to reduce reactive organic gas emissions from organic waste operations, identified as commitment S-GOV-5 in the 2007 Ozone Plan. There is no change to the implementation date or the expected emission reductions. The additional time for rule development is necessary to collect more scientific and technical data relating to the control of emissions from those operations. There is no impact to the attainment and Reasonable Further Progress demonstrations in the 2007 Ozone Plan.
