Dear Ms Yoshii:

The Air Resources Board (ARB or Board) hereby submits to the U.S. Environmental Protection Agency (U.S. EPA) the San Joaquin Valley Air Pollution Control District's (District) 2009 Reasonably Available Control Technology Demonstration for Ozone State Implementation Plans (2009 RACT SIP).

The 2009 RACT SIP was developed to satisfy the needs of an area classified as "Extreme" nonattainment of both the now-revoked federal 1-hour ozone standard and the 1997 federal 8-hour ozone standard. Accordingly, the 2009 RACT SIP replaces the previous submittal of the 2006 RACT SIP, which demonstrated that the District had met the federal RACT requirements for a "Serious" nonattainment area. Federal approval of the 2009 RACT SIP will also terminate the sanction clocks that were started when U.S. EPA found that California failed to submit a RACT demonstration as required for an area designated nonattainment of the now-revoked federal 1-hour ozone standard.

The 2009 RACT SIP demonstrates that, in many cases, the District's regulatory program goes beyond the minimum control requirements established by the federal RACT program to reduce ozone forming emissions through the use of the best available retrofit emission control technologies.


