### NOTICE OF PUBLIC MEETING TO CONSIDER APPROVAL OF THE IMPERIAL COUNTY 2009 1997 8-HOUR OZONE MODIFIED AIR QUALITY MANAGEMENT PLAN AND 2009 REASONABLY AVAILABLE CONTROL TECHNONOLGY STATE IMPLEMENTATION PLAN

The Air Resources Board (ARB or Board) will conduct a public meeting at the time and place noted below to consider the approval of the proposed Imperial County 2009 1997 8-Hour Ozone Modified Air Quality Management Plan (2009 Ozone Plan) and 2009 Reasonably Available Control Technology State Implementation Plan (2009 RACT SIP) for the Imperial County Nonattainment Area. If approved by the Board, ARB will submit the 2009 Ozone Plan and 2009 RACT SIP to the United States Environmental Protection Agency (U.S. EPA) for approval as a revision to the California State Implementation Plan (SIP).

This item may be considered at a two-day Board meeting, which will commence at 9:00 a.m., November 18, 2010, and may continue at 8:30 a.m., on November 19, 2010. This item may not be considered until November 19, 2010. Please consult the agenda for the meeting, which will be available at least ten days before November 18, 2010, to determine the day on which this item will be considered.

#### **Background**

The federal Clean Air Act (CAA) establishes planning requirements for areas that exceed the health-based National Ambient Air Quality Standards (NAAQS) and have been designated as nonattainment based on monitored exceedances of the NAAQS. Nonattainment areas must develop and implement SIPs that demonstrate how they will attain the NAAQS by specified dates.

In 2004 U.S. EPA identified Imperial County as a "marginal" nonattainment area for the 8-hour ozone NAAQS promulgated in 1997. On February 13, 2008, U.S. EPA found that Imperial County had not attained the 1997 8-hour ozone NAAQS by the marginal area attainment deadline of June 15, 2007, and reclassified it as a "moderate" nonattainment area. Under the CAA, this action requires California to submit as a SIP

revision a moderate area ozone plan for Imperial County, demonstrating attainment of the 8-hour ozone NAAQS by June 15, 2010.

On February 19, 2009, ARB submitted a clean data finding request for Imperial County to U.S. EPA. The request was based on certified air monitoring data recorded from 2006 through 2008 that indicated attainment of the 1997 8-hour ozone NAAQS. In response to ARB's request, on December 3, 2009, U.S. EPA published in the Federal Register its determination that Imperial County attained the 1997 8-hour ozone standard. This action suspended some CAA nonattainment area plan requirements. However, California is still required to submit revisions to the SIP to address remaining elements required for moderate ozone nonattainment areas, including rule review and adoption relative to the reasonably available control technology (RACT) requirements, emission inventories, and new source review requirements.

On July 30, 2010, the Imperial County Air Pollution Control District adopted the 2009 Ozone Plan and 2009 RACT SIP to address the CAA moderate area plan requirements.

# Proposed Action

ARB staff has reviewed the Imperial County 2009 Ozone Plan and 2009 RACT SIP, and consulted with District staff during its review. ARB staff finds that the Imperial County 2009 Ozone Plan and 2009 RACT SIP meet all applicable CAA requirements for a moderate nonattainment area. Staff recommends that the Board approve the Imperial County 2009 Ozone Plan and 2009 RACT SIP and direct the Executive Officer to submit them to U.S. EPA as revisions to the California SIP.
