**RESOLUTION APPROVING THE
EIGHT-HOUR OZONE ATTAINMENT PLAN
FOR SAN DIEGO COUNTY**

On motion of Member ~~Slater-Price~~, seconded by Member Cox,
the following Resolution is adopted:

WHEREAS, the federal Clean Air Act requires the U.S. Environmental Protection Agency (EPA) to establish health-protective ambient air quality standards for common outdoor air pollutants, including ozone; and

WHEREAS, the U.S. EPA has established a national eight-hour-average ambient air quality standard for ozone at a level of 0.08 parts per million; and

WHEREAS, the Clean Air Act requires any area that does not meet a national ambient air quality standard for a pollutant to be designated nonattainment for that pollutant; and

WHEREAS, the national eight-hour ozone standard is not yet attained in San Diego County, notwithstanding the achievement of significant progress over the past two decades in improving the region's ozone air quality; and

WHEREAS, the U.S. EPA has designated San Diego County as a nonattainment area for the national eight-hour ozone standard; and

WHEREAS, pursuant to federal requirements, by June 15, 2007, the San Diego County Air Pollution Control District (District) must submit to the U.S. EPA, through the California Air Resources Board (ARB), a State Implementation Plan outlining the combination of local, State, and federal emission control regulations necessary to provide for eight-hour ozone attainment by June 15, 2009; and

WHEREAS the District has prepared an Eight-Hour Ozone Attainment Plan meeting or surpassing applicable requirements of the Clean Air Act and federal regulations; and

WHEREAS, a notice of a public hearing and opportunity for public comment on the proposed Eight-Hour Ozone Attainment Plan were published at least 30 days prior to the public hearing; consistent with requirements of the Clean Air Act and federal regulation; and

WHEREAS, pursuant to the California Environmental Quality Act, the District prepared an Initial Study, which found no substantial evidence that the proposed Eight-Hour

Ozone Attainment Plan may have a significant adverse impact on the environment and, consequently, a Negative Declaration was prepared and certified.

NOW, THEREFORE, BE IT RESOLVED that the Air Pollution Control Board approves the Eight-Hour Ozone Attainment Plan for San Diego County; and

BE IT FURTHER RESOLVED that the Air Pollution Control Board directs the Air Pollution Control Officer to submit this resolution and the accompanying Eight-Hour Ozone Attainment Plan to the ARB for expeditious submittal to the EPA.
