**Note: Use this form only if the engine or equipment unit has an existing registration with the Air Resources Board (ARB).**

1. **Registration To Be Issued To (Company Name)** - Legal name of entity, business, organization, agency, or private individual that operates equipment.
2. **Mailing Address** - Address where all business correspondence is to be mailed.
3. **Street Address** - Location where equipment is stored when not operated. If left blank, we will assume street address is the same as mailing address. Street address cannot be a P.O. Box.
4. **Company Information** - The email, phone, and fax numbers need to belong to the company, not a third party. Examples of third party members are consultants, distributors, sales representatives, lawyers, etc.
5. **General Nature of Business** - Please state the type of business conducted by entity seeking registration. Examples include construction operations, renter of portable equipment, solid waste facility, oil drilling rig operations, etc.  
**Rental Business/Agricultural Source** - Please check "Yes" or "No" as appropriate. A *rental business* means a business where the principal use of its engines or equipment units is to temporarily rent or lease for profit portable engines or equipment units to operators other than the owner(s) of the engine or equipment unit. An *agricultural source* according to Health and Safety Code section 41705 is an "agricultural operation necessary for the growing of crops or the raising of fowl or animals." Any engine or equipment unit that operates on an agricultural source must also meet the definition of "portable" according to the Portable Equipment Registration Program Regulation to be admitted.
6. **Serial Number** – The serial number of the engine or equipment unit.
7. **Registration Number** – The number shown on the existing registration certificate and sticker.
8. **Company unit I.D. number** - This is the number your company uses to identify the unit.
9. **New Home District** - Home district can only change during a renewal. So if a renewal is being done along with the change of ownership, it should be updated. The home district is the air district where the unit operates most often.
10. **Two-engine vehicles and vessels** - Portable auxiliary diesel engines on two-engine vehicles and commercial harbor craft vessels can be subject to other State diesel regulations as well as air district permitting or PERP registration. Check "Yes" if this is the case. These engines must be in compliance with those regulations before we can process the application for PERP registration. ARB will determine if the engine is in compliance before acting on this application. Note that compliance with the Portable Diesel Fleet Standards is excluded for portable engines on two-engine vehicles and commercial harbor craft.
11. **Fleet Compliance Report** – If your application includes a diesel engine that does not meet the current fleet standard for the applicable power category of the engine (other than a crane, sweeper, water well drilling rig, or snow blower), you must include a statement of compliance and fleet summary, as described in the Portable Diesel Engine ATCM section 93116.4(e)(2). This applies to diesel engines only. It does not apply if the application is for an equipment unit or a spark-ignition engine. 12. **Fees** – The fee is \$75.00 but if the registration is within 5 months of expiration or is expired, the renewal fees also need to be paid at this time. The following fees apply depending on multiple engine inspection discount level. You can claim the discount if you can assure that the appropriate number of engines will be at one location available for inspection by the air district inspector. The discount amounts only apply to engines, not equipment units:

Engines	Renewal	Change of Ownership	Total
No discount:	\$570.00	\$75.00	\$645.00
Engines with 25% discount (4 – 9 engines inspected at one time):	\$483.75	\$75.00	\$558.75
Engines with 35% discount (10 or more engines inspected at one time):	\$449.25	\$75.00	\$524.25
Equipment units (no discount available):	\$300.00	\$75.00	\$375.00

If the unit is missing the green metal placard, add \$5.00 for each placard needed.

**Important - The 25 percent discount requires 4 to 9 engines and the 35 percent discount requires 10 or more engines to be inspected together. Failure to have the engines at the agreed upon location may result in district enforcement action.**

Payment may be by check or credit card. Use the *Credit Card Authorization Form (ASD/FISCAL 307)* to pay by credit card.

13. **Printed Name of Responsible Party** - Responsible Party is the individual employed or otherwise retained by a company, public agency, or municipality that has the authority to certify that the portable equipment complies with all applicable requirements of the PERP regulation. This person must be a direct employee to the company, not a third party. Examples of third party members are consultants, distributors, sales representatives, lawyers, etc.
14. **Signature of Responsible Party with Date** - Application will not be accepted unless signed and dated.
