FINAL REGULATION ORDER

Add Title 13, California Code of Regulations, section 2292.1, footnote (e) which reads as follows:

2292.1 Fuel Specifications for M100 Fuel Methanol

The following standards apply to M-100 fuel methanol

Luminosity		Shall produce a luminous flame, which is visible under maximum daylight conditions, throughout the entire burn duration. Applicable 1/1/95. ^(e)

^(e) This requirement shall not apply where the person selling, supplying, or using the M100 fuel methanol demonstrates that it will be used as a motor vehicle fuel only in vehicles that are equipped with a system for automatically detecting and suppressing on-board fires or a system for on-board luminosity enhancement.
