Project Description: The project is amending the Heavy-Duty Vehicle Greenhouse

Gas (GHG) Emission Reduction regulation originally approved in December 2008 to reduce emissions of greenhouse gases from 53-foot and longer box-type trailers and the tractors that haul such trailers in California. The existing regulation is being amended to establish a second compliance schedule to allow trailer fleets to phase-in compliance from 2011 through 2015,

to provide fleets with additional flexibility to meet the

requirements of this regulation, such as by providing flexibility in

complying with existing fleet reporting requirements, and including temporary, short-term exemptions for specific circumstances. These amendments will provide affected tractors, trailers, and fleets additional flexibility to ease their burden of compliance, and in some cases reduce compliance

costs.
