FOR THE VAPOR RECOVERY EQUIPMENT LIST REGULATION

The Office of Administrative Law (OAL) is authorized to make the following corrections, substitutions, and additions in connection with the above-referenced rulemaking:

- (1) Correct the Form 400 with the following:
 - a. B.4. Correct the First 15-Day Availability starting date from February 15, 2012 to February 16, 2012.
- (2) Substitute page16 of the Document Incorporated by Reference" Vapor Recovery Equipment Defects List" (five copies provided).
- (3) Add to Tab 3 the enclosed Addendum to the Final Statement of Reasons.
- (4) Substitute the revised Table of Contents in front of Tab 1 of the rulemaking file, which was corrected to add the Addendum to the FSOR and the Test Procedures.
- (5) Remove Test Procedures from the one set of these that were provided with the rulemaking text. The Following Test Procedures were inadvertently included in the file but should be removed because they had previously been included in the Defects List.
