### I. Background

On August 8, 2014, the Air Resources Board (ARB or Board) submitted the Final Statement of Reasons (FSOR) for the Amendments to the Alternative Fuel Conversion Certification Procedures for On-Road Motor Vehicles and Engines to the Office of Administrative Law (OAL) for its review and approval. In the course of its review, OAL identified several issues with the FSOR. Each of these issues is addressed below.

#### II. CORRECTIONS TO THE FSOR

During OAL's review period, OAL requested additional changes to the Final Statement of Reasons. These changes included adding four comments received during the 45-day comment period which were not addressed in the Final Statement of Reasons because the \*comments received were not relevant to the rulemaking action. Therefore, those comments do not require a response because they do not constitute objections or recommendations specifically directed at the proposed action or to the procedures followed by ARB in proposing or adopting the rulemaking action.
