NOTICE OF PUBLIC MEETING TO CONSIDER APPROVAL OF THE CALIFORNIA INFRASTRUCTURE SIP

The Air Resources Board (ARB or Board) will conduct a public meeting at the time and place noted below to consider the approval of proposed revisions to the California Infrastructure State Implementation Plan (SIP) for submittal to the United States Environmental Protection Agency (U.S. EPA). The proposed revisions to the SIP are administrative in nature and describe the authorities, resources, and programs California has in place to implement, maintain, and enforce the National Ambient Air Quality Standards (federal standards or standards). The proposed revisions do not contain any proposals for emission control measures. The federal standards covered by the proposed Infrastructure SIP are those for ozone, fine particulate matter (PM_{2.5}), lead, nitrogen dioxide (NO₂), and sulfur dioxide (SO₂).

This item will be considered at a one day meeting of the Board, which will commence at 9:00 a.m., January 23, 2014. This item is scheduled to be heard on the Board's Consent Calendar. Items on the Consent Calendar are scheduled to be voted on by the Board immediately after the start of the public meeting. Any item may be removed from the Consent Calendar by a Board member or at the request of a Board member or if someone in the audience would like to speak on that item.

Infrastructure SIP requirements are specified in Section 110 of the federal Clean Air Act (CAA) and in U.S. EPA's implementing regulations. Examples of infrastructure elements include authority to adopt, implement, and enforce regulations, and demonstration of sufficient personnel and resources to implement the federal standards. The CAA refers to these collectively, as the necessary "infrastructure." The Infrastructure SIP describes the programs in place to address these elements and provides reference to the authority under which the programs are administered. Under the CAA, states are required to submit an Infrastructure SIP to U.S. EPA within three years of the promulgation of each new or revised federal standard.

The overarching framework or infrastructure for California's air quality programs is well established, and most of the Infrastructure SIP elements were addressed in California's comprehensive Infrastructure SIP, submitted to meet the requirements the 1970 CAA

and approved by U.S. EPA in 1979 (40 Code of Federal Regulations Part 52.220). ARB has submitted several Infrastructure SIP revisions since that time in response to new or revised federal standards. The most recent revisions addressed requirements for the recently promulgated federal lead and NO₂ standards. The proposed Infrastructure SIP revisions that are the subject of this notice build on California's previous submittals. The federal standards covered in the proposed Infrastructure SIP are summarized in Table 1.

This update, which constitutes a revision to California's overall SIP, addresses the required infrastructure elements, including California's ability and authority to monitor and report emissions and air quality data, to adopt and enforce regulations and programs designed to protect public health, to provide opportunity for input and review by affected entities and the public, to provide for Board composition and conflict of interest disclosure that conforms with federal requirements, and to maintain adequate personnel and resources to implement the required programs. New provisions required by the recent revisions to federal standards are limited in scope and are focused on California's compliance with new monitoring requirements – specifically, the deployment of newly required near-roadway monitors for NO₂ and PM_{2.5}. Because of their general nature, many elements of the proposed Infrastructure SIP will apply to any future new or revised standards that U.S. EPA promulgates.

ARB staff has prepared a proposed Infrastructure SIP that documents the required infrastructure elements and will ask the Board to approve the proposed Infrastructure SIP. If approved, staff will transmit the Infrastructure SIP to U.S. EPA. Upon approval by U.S. EPA, the Infrastructure SIP will be incorporated as a revision to California's overall SIP.

ARB staff will present a written report at the meeting. 
