## Notice of Decision

**Project Title:** Re-Adoption of the Low Carbon Fuel Standard Regulation  
(SCH# 2014122073)

**Project Location:** Statewide

**Public Meeting Dates:** February 19, 2015 and September 24-25, 2015; Agenda Item #15-7-2

**Project Description:** Re-adoption of the Low Carbon Fuel Standard (LCFS) Regulation will reduce emissions of greenhouse gases (GHG) by lowering the carbon content of transportation fuels used in California and achieve other benefits that will: diversify the State's fuel portfolio; reduce dependence on petroleum; create a lasting market for clean transportation technology; and stimulate the production and use of alternative, low carbon fuels in California.

This notice is to advise that the California Air Resources Board (ARB or Board), as the lead agency, adopted the above regulatory proposal on September 25, 2015.

ARB prepared a draft environmental analysis under its certified regulatory program (Cal. Code Regs., tit. 14, §15251, subd, (d)) that covered both the LCFS regulation and the Regulation on the Commercialization of Alternative Diesel Fuels (ADF) in the document entitled *Draft Environmental Analysis Prepared for the Low Carbon Fuel Standard and Alternative Diesel Fuel Regulations* (Draft EA). The Draft EA was included as Appendix D to the respective Initial Statement of Reason (ISOR) prepared for each of the proposed regulations, and circulated for public review and comment from January 2, 2015 through February 17, 2015.

The Draft EA found that although the policy aspects and requirements of the proposed ADF and LCFS regulations do not directly change the physical environment, there are potential indirect physical changes caused by reasonably foreseeable actions undertaken by entities in response to the proposed regulations. Staff prepared written responses to comments received that raised environmental issues regarding these proposals during the comment period. The written responses to these environmental comments are included in a document entitled *Response to Comments to the Environmental Analysis prepared for the Re-Adoption of the Low Carbon Fuel Standard and Alternative Diesel Fuel Regulation*. Following the public hearing held on September 24, 2015, staff prepared written responses to additional comments received at the hearing raising environmental issues in a document entitled *Supplement to the Responses to Comments on the Draft Environmental Analysis for the Low Carbon Fuel Standard and Alternative Diesel Fuel Regulations*. Staff also prepared the Final EA, which includes minor revisions to the Draft EA.

Before taking action on the proposed regulation, the Board considered and approved the written responses to Draft EA comments as required by ARB's certified regulations (Cal. Code Regs., tit. 17, §60007(a)) and certified the Final EA. The Board adopted findings and a statement of overriding considerations as part of its action on the proposed regulation.
