Pursuant to your findings in review of the above-referenced Rulemaking, the Air Resources Board (ARB) hereby authorizes you to correct the rulemaking record as follows:

1. Substitute the enclosed six copies of the revised "Final Regulation Order" and the revised incorporated "California Exhaust Emission Standards and Test Procedures for 2001 and Subsequent model Passenger Cars, Light-Duty Trucks, and Medium-Duty Vehicles behind each copy of the Form 400 (seven copies provided).
