NOTICE OF PUBLIC MEETING TO PROVIDE A BRIEFING ON SENATE BILL 375 IMPLEMENTATION STATUS

The Air Resources Board (ARB or Board) will conduct a public meeting at the time and place noted below to receive a briefing on the status of implementation of the Sustainable Communities and Climate Protection Act of 2008 (SB375), including the status of Sustainable Communities Strategies (SCS) adopted to date, and ongoing work by Metropolitan Planning Organizations (MPO) to adopt and implement their first SCSs.

This item may be considered at a two-day meeting of the Board, which will commence at 9:00 a.m., January 23, 2014, and may continue at 8:30 a.m., on January 24, 2014. This item may not be considered until January 24, 2013. Please consult the agenda for the meeting, which will be available at least 10 days before January 23, 2014, to determine the day on which this item will be considered.

In September 2010, the Board set passenger vehicle greenhouse gas (GHG) emission reduction targets for 2020 and 2035 for each of the MPO regions in California, pursuant to SB375. The law requires that each MPO adopt an SCS or an Alternative Planning Strategy that, if implemented, would achieve the targets established by the Board. Since 2010, several MPOs have adopted an SCS, and others will be adopting an SCS in 2014. Staff will brief the Board on the status of SB375 implementation including the staff's evaluation of SCSs adopted to date by several MPOs, progress in implementing currently adopted SCSs, ongoing development of data and tools for future planning activities, and next steps in the implementation of SB375.

Staff will provide an oral briefing and a PowerPoint presentation will be available on the date of the meeting. No written reports are being provided as part of this item.

Interested members of the public may present comments verbally or in writing at the meeting and may be submitted by postal mail or by electronic submittal before the meeting. To be considered by the Board, written comments not physically submitted at the meeting must be received **no later than 12:00 noon, January 22, 2014**, and addressed to the following:


