NOTICE OF PUBLIC MEETING TO CONSIDER THE AIR RESOURCES BOARD AND CALIFORNIA AIR POLLUTION CONTROL OFFICERS' ASSOCIATION RISK MANAGEMENT GUIDANCE FOR STATIONARY SOURCES OF AIR TOXICS

The Air Resources Board (ARB or Board) will conduct a public meeting at the time and place noted below to consider the ARB and California Air Pollution Control Officers' Association (CAPCOA) Risk Management Guidance for Stationary Sources of Air Toxics.

This item will be heard at a one-day meeting of the Board, which will commence at 9:00 a.m., July 23, 2015. Please consult the agenda for the meeting, which will be available at least 10 days before July 23, 2015, to determine the order in which this item will be considered.

Background

California's Air Toxics Program was created in the 1980's through the passage of the Toxic Air Contaminant Identification and Control Act of 1983 (Assembly Bill (AB) 1807), and the Air Toxics "Hot Spots" Information and Assessment Act of 1987 (AB 2588), for the purpose of reducing air toxic emissions and related health impacts to Californians. Over the last 25 years, California has successfully reduced air toxics emissions and related health impacts from exposures to air toxics by approximately 75 percent. During this same period, the economy grew by 83 percent and the number of residents and vehicles increased by approximately 9 million and 8 million, respectively. Several programs at the State level and at local Air Pollution Control Districts and Air Quality Management Districts (Districts), along with investments by industry in cleaner operations and technology and input by the public and environmental community, are the reasons for this success.

On March 6, 2015, the Office of Environmental Health Hazard Assessment (OEHHA) released the Air Toxics Hot Spots Program Risk Assessment Guidelines: Guidance Manual for the Preparation of Health Risk Assessments. This document contains the new risk assessment methodology that addresses the latest scientific information on childhood sensitivities and the most recent data on childhood and adult exposure to air

toxics. It makes use of data accumulated since the passage of the Children's Health Protection Act of 1999 (SB 25), which required OEHHA to ensure infants and children are explicitly addressed in assessing risk. The use of the new risk assessment methodology may result in higher estimated cancer risk than what would have been calculated using the previous 2003 OEHHA risk assessment methodology for the same level of emissions and conditions.

In general, the higher estimated risks mean that new or modified stationary sources of toxics may need additional emissions control. For existing stationary sources that comply with current air toxic rules, additional emissions control may be needed since higher estimated risk using the new methodology might exceed the District's risk reduction levels for AB 2588 Hot Spots requirements. ARB and the Districts are re-evaluating their programs to determine if adjustments may need to be made to permitting, source specific regulations, and other toxic-related programs.

ARB and CAPCOA have worked closely together to develop the proposed Risk Management Guidance for Stationary Sources of Air Toxics. This document includes a staff report that describes California's Air Toxics Program, progress to date, and plans to review the effectiveness of existing regulations for both stationary and mobile sources. It also contains three stand-alone guidance documents that can be used by California's 35 Districts for incorporating the new risk assessment methodology into their stationary source permitting and AB 2588 Hot Spots Program. The proposed Risk Management Guidance is intended to help Districts with their re-evaluation process and to communicate ARB and the Districts' plans, priorities, and policies regarding implementation of the new OEHHA risk assessment methodology. When approved, this document will supersede ARB's Risk Management Guidelines for New and Modified Sources of Toxic Air Pollutants (1993). The proposed Risk Management Guidance provides the updated Risk Management Policy for Inhalation Risk Assessments which replaces the ARB's Interim Risk Management Policy for Inhalation based Residential Cancer Risk (2003).

ARB staff will present the proposed Risk Management Guidance at the meeting.


