This item will be considered at any time during a meeting of the Board, which will commence at 9:00 a.m., September 28, 2017, and may continue at 8:30 a.m. on September 29, 2017. Please consult the agenda for the meeting, which will be available at least ten days before September 28, 2017.

Background

ARB is updating its enforcement policy partly to respond to Assembly Bill (AB) 1685 (Stat. 2016, ch.604 §§ 1 to 6; Health & Saf. Code §§ 43016, 43151, 43154, 43211, 43212, 43214) which, among other things, increases the maximum penalties for mobile source violations and clarifies how those penalties can be applied. In addition to updating the current policy to address AB 1685, staff took this opportunity to develop a more comprehensive enforcement policy. The goals include providing more clarity on compliance resources available, ARB's enforcement process, considerations in determining appropriate penalties, voluntary disclosure considerations, minor violations, public communication and information protection.

Proposed Action

ARB staff will present a written copy of the draft Enforcement Policy at the meeting. 
