### NOTICE OF PUBLIC MEETING TO CONSIDER THE 2016 OZONE SIP FOR VENTURA COUNTY

The Air Resources Board (ARB or Board) will conduct a public meeting at the time and place noted below to consider the adoption of the *2016 Ventura County Air Quality Management Plan* (2016 Plan) developed by the Ventura County Air Pollution Control District (Ventura County or the District) for the 75 parts per billion (ppb) 8-hour ozone standard. If adopted, ARB will submit the 2016 Plan to the United States Environmental Protection Agency (U.S. EPA) as a revision to the California State Implementation Plan (SIP).

This item will be considered at a two-day meeting of the Board, which will commence at 9:00 a.m., March 23, 2017. This item is scheduled to be heard on the Board's Consent Calendar. All agenda items on the Consent Calendar – unless removed upon the request of a Board member or if someone in the audience submits a request to speak card on that item – will be voted on by the Board at the beginning of the public meeting.

#### **Background**

The federal Clean Air Act (CAA) establishes planning requirements for areas that exceed the health-based National Ambient Air Quality Standards (NAAQS). These nonattainment areas must develop and implement a SIP that demonstrates how they will attain the standard by specified dates.

In 2008, U.S. EPA strengthened the 8-hour ozone standard (Standard) to 75 parts per billion. On July 20, 2012, U.S. EPA designated and classified Ventura County as a Serious nonattainment area. The District must develop a plan that addresses the Serious planning requirements and demonstrates attainment of the Standard by 2020. The District prepared the 2016 Plan to address these requirements and the Governing Board approved it on February 14, 2016.

The 2016 Plan includes a comprehensive emission inventory, attainment demonstration, reasonable further progress (RFP) demonstration, assessment of reasonably available control measures and technologies, and identification of

contingency measures if Ventura County fails to meet an RFP milestone or attain the standard. The 2016 Plan also includes motor vehicle transportation conformity budgets developed using the EMFAC2014 emissions model that reflects the latest planning assumptions.

ARB staff has reviewed the 2016 Plan and has concluded that it meets the applicable Act requirements.

### **Proposed Action**

ARB staff recommends that the Board adopt the 2016 Plan for Ventura County and direct staff to submit the 2016 Plan to U.S. EPA as a revision to the California SIP.

ARB staff has prepared a written report. 
