The California Air Resources Board (CARB or Board) is hosting the first joint public meeting between CARB and the California Transportation Commission (CTC or Commission) at the time and place noted below to discuss transportation policies and program coordination pursuant to Assembly Bill (AB) 179.

This meeting will commence at 1:00 p.m. on June 27, 2018. Please consult the agenda for the meeting, which will be available at least ten days before June 27, 2018.

This meeting of the Board and Commission is separate from the June Board hearing and will not be on the June Board agenda.

Background

Under AB 179 (Cervantes, Chapter 737, 2017), CARB and CTC will conduct at least two joint meetings per calendar year to coordinate their implementation of transportation policies, including, but not limited to: implementing the Sustainable Freight Action Plan, developing the California Transportation Plan update, and setting Sustainable Community Strategy greenhouse gas emission reduction targets.

These meetings will include discussions of CARB and CTC transportation programs, policies, and goals and identification of synergies between the two agencies. These joint meetings will allow for a better understanding by CARB, CTC, and the public of the connections between CARB and CTC transportation policies and programs. The continued, coordination between CARB, CTC, other State and local transportation agencies, and the public through this joint meeting process will help support meeting air quality, climate, and equity goals in addition to the State's most critical transportation needs.

Joint meetings will be more informal than Board or Commission meetings. Presentations will facilitate open dialogue amongst the Board, Commission, and the

public, highlight opportunities for enhanced coordination, and show synergies in our program priorities. There will be a dedicated time allotted for public comments and questions to allow for direct engagement with Board members and Commissioners.

Interested members of the public may present comments orally or in writing at the joint meeting and may provide comments by postal mail or by electronic submittal before the meeting.
