PUBLIC WORKSHOPS TO DISCUSS THE CALIFORNIA STUDY OF ENVIRONMENTAL HEALTH CONDITIONS IN PORTABLE CLASSROOMS

Dear Sir or Madam:

This notice is an update to our prior notice. Please see new dates and times below.

The California Air Resources Board (ARB) and the California Department of Health Services (DHS) invite you to participate in one of the upcoming workshops to discuss a draft report to the California Legislature on a comprehensive study of the environmental health conditions in California's portable classrooms. The workshops will be held **June 24, 2003** in Sacramento and on **June 25, 2003** in Diamond Bar (Los Angeles area).

The California Portable Classrooms Study was proposed by Governor Davis and is part of a legislative mandate specified in California Health and Safety Code Section 39619.6. The ARB and the DHS are jointly conducting the study, with the main research field effort conducted by Research Triangle Institute, a research consulting organization. Based on the research study results and other available information, the ARB and the DHS staff have developed a draft report that includes recommendations for preventing or reducing unhealthful environmental conditions in California classrooms.

The workshops are designed to: (1) provide information on the results of the research study, and (2) obtain comments and suggestions from interested parties regarding the draft report to the Legislature, including the draft recommendations. The draft report to the Legislature is expected to be available on our website on Thursday, June 12, 2003, at <http://www.arb.ca.gov/research/indoor/pcs/pcs.htm>.
