Dear Sir or Madam:

We would like to invite you to attend a public workshop to discuss the draft report, Proposed Identification of Environmental Tobacco Smoke as a Toxic Air Contaminant, December 2003. The report is available on-line at [www.arb.ca.gov/toxics/ets/ets.htm](http://www.arb.ca.gov/toxics/ets/ets.htm).

Since June 2001, the Air Resources Board (ARB) and the Office of Environmental Health Hazard Assessment (OEHHA) have investigated the exposure and health effects of environmental tobacco smoke (ETS) to determine whether it meets criterion to be identified as a toxic air contaminant (TAC). State law directs ARB to identify and control toxic air pollutants which pose a potential public health risk to Californians (Health and Safety Code, sections 39650-39674).

As a result of its evaluation, ARB and OEHHA have jointly prepared a draft report to evaluate the need to identify ETS as a TAC. This report was released to the public in December 2003. We are extending the comment period on the report. Comments on the draft report are now due by March 29, 2004.

The staff of ARB and OEHHA have scheduled a public workshop to discuss the draft report at the following date, time, and location:

The ARB and OEHHA staffs will present responses to the comments along with the revised report at a future SRP meeting yet to be scheduled.
