

Modification Highlights for Executive Orders VR-203/204 Revision P

Part I: Executive Order

All Exhibits:

- Changed all footers and headers to reference VR-203-P and VR-204-P.

Legal Language:

- Added “whereas” paragraph describing the nature of the amendment request to include the VST-EVR-NB (G2) nozzle as an alternate nozzle.
- Extended expiration date from April 1, 2014 to April 1, 2015 to gather necessary information to complete a renewal evaluation.
